31 May 2022, marks the 48th anniversary of the establishment of diplomatic relations between People's Republic of China and Malaysia. The two countries, having been good friends and friendly neighbours for thousands of years, started a brand-new journey in 1974, based on the principles of mutual respect and peaceful coexistence. These 48 years have witnessed our sturdy friendship and genuine brotherhood tested and consolidated by numerous challenges and difficulties.

Generations of leaders from both countries contributed enormously in enhancing the friendly relations between the two countries. High quality Belt & Road cooperation projects such as the East Coast Rail Link (ECRL), which had achieved nearly 30% fulfilment despite the Covid-19 pandemic, will act as a strong driving force to prosper the local economy and bring benefit to local people.

Mutual assistance is the bedrock of China-Malaysia friendship. The well-known story of Admiral Zheng He (Cheng Ho), who had visited Melaka five times during his seven voyages, is a good example to prove the thousands of years long friendship between the two countries. From the start of diplomatic relations 48 years ago, the two countries have

When COVID-19 pandemic broke out in China, Malaysia acted fast to send out essential supplies to China. In the same way, China have sent millions of Chinese made vaccines to assist Malaysia's "National COVID-19 Immunisation Programme" which is crucial to curb the pandemic and effectively protect Malaysian people.

Now, the world is undergoing complex and profound changes. Despite multiple instabilities and uncertainties, China is determined to keep its highquality development mode, which acts as a strong force to maintain and ensure global economy to develop in a positive manner. Malaysia is now focusing on implementing the 12th Malaysia Plan while striving hard to achieve the Shared Prosperity Vision 2030. MALAYSIA-CHINA ECONOMIC COOPERATION

diplomatic relations between Malaysia and the People's Republic of China began on 31 May 1974, and this year, we chronicled 48 years of the enduring friendship between the two nations. Since entering into the Covid pandemic on 1 April 2022, Malaysians have learned to accept Covid as endemic and get back to normality. long-stalled Malaysia-China economic and trade cooperation over the past two years is recovering and, in that process, revitalising industries of various sectors with the revival of political and business communication between the two countries. As of 9 August 2022, based on Ministry of Health data, the vaccination drive against COVID-19 in Malaysia has progressed smoothly, with 84.8% of the population fully vaccinated. Following the full withdrawal of movement restrictions, economic activities in Malaysia continued to normalise. Amidst a broad-based improvement, Malaysia's GDP growth accelerated in the first quarter of this year, registering a positive growth of 5.0%.

Waves of Malaysia's Economic Challenges

Amidst the regional and global crises which contributed to the rising inflation rate and disruptions in the supply chains, Malaysians have felt the brunt of these trying times. In June 2022, Malaysia's Consumer Price Index (CPI) rose to a one-year high of 3.4%, with the Food and Non-Alcoholic Beverages Index 6.1%. the increasina to major contributor to the rise in inflation. Furthermore, as a net importer of foods, Malaysia incurred higher imported inflation, and rising prices of animal feed and fertilisers, along with an increase in wages and prolonged supply disruptions, have added to rising production costs and contributed to the higher inflation rate.

The ongoing global geopolitical, socioeconomic, and inflationary pressures and our over-reliance on food imports have been attributed to the depreciation of our Malaysian Ringgit. However, with the revival of our economy, the depreciation of the Ringgit [and the lowest unemployment]

rate since the outbreak of COVID-19] will help in attracting foreign direct investments and increased exports. In addition to the resumption of the tourism industry, the weaker Ringgit would turn Malaysia into an attractive destination, boosting the hospitality and aviation sectors and stimulating domestic economic growth.

Overcoming the Tides Together

China is a strong advocate of mutual prosperity and stability to promote global peace and harmony. Likewise, building economic resilience and sustainable development reflects its efforts to strengthen its relations with its neighbours. As ASEAN and Malaysia's trading partner for largest consecutive years since 2009, China will continue to work together despite the difficulties and challenges to promote our mutual comprehensive strategic partnership.

Malaysia expects Chinese tourists to return in large numbers once Beijing relaxes travel restrictions for its citizens. It eagerly awaits the return of Chinese visitors to boost the country's foreign revenue. as China is a contributor to tourism in the ASEAN region. Furthermore, under the framework of the Belt and Road Initiative (BRI) and Regional Comprehensive Economic Partnership (RCEP), Malaysia and China will work complementarily with each other to expand cooperation in traditional industries as well as to develop a

globally interconnected international trade connectivity which could enhance trade resilience and promote sustainable development. An open strategy for developing and promoting regional economic integration will drive cooperation in science, technology, and innovation to stimulate digital transformation for high-quality post-COVID-19 economic recovery.

Sailing Forward

MCBC firmly believes in deepening cooperation with China to jointly focus on dialogues, trade & investment, and economic development. Malaysia and China have enjoyed close to half a century of the brotherly bonds in sharing wealth and woes, throughout this journey, we have bore witness to the close ties which are reflected in the broad range of investments and business collaborations between the two countries. MCBC would like to continue to be the bridge and the driver of change for Malaysia and China in enhancing cooperation across trade & investment, green economy, peopleto-people exchanges, technology transfer, food security, tourism, etc., to deepen communication capitalise on the business opportunities in the post-COVID era.



UNLOCKING THE VITALITY OF SOUTH-SOUTH COOPERATION

BRICS AND BRICS PLUS: WHAT IT MEANS FOR MALAYSIA

outh-south cooperation refers to cooperation among emerging markets and developing countries (EMDCs) in the Global South governments, international organisations, academics, and the private sector share knowledge, skills, and successful initiatives in specific sectors such as agricultural development and urbanisation, poverty alleviation, climate change, etc.

BRICS is a unique trans-continental multilateral forum that brings together the five major developing countries, namely: Brazil, Russia, India, China, and South Africa, which represent a quarter of the world's GDP, 41% of the world's population, and 16% of the world's **BRICS** trade. was founded September 2006 and held its 1st BRIC Summit in June 2009 on the principles of non-interference, equality, and mutual benefit to uphold the three pillars of BRICS - political and security, economic and financial, and cultural and peopleto-people exchanges.

Since then, BRICS has held annual summits amongst its members. This year,

on 23 June 2022, China chaired the 14th BRICS Summit and the High-Level Dialogue on Global Development, assembling the globally powerful emerging markets and developing countries to determine the consensus on the direction of the global economy over the next decade. As the BRICS members are among the largest economies in the world, two financial instruments of the BRICS countries, the New Development Bank (NDB) and the Contingent Reserve Arrangement (CRA), were developed to support public or private projects within the Global South and to provide protection against global liquidity respectively.

Over the past 16 years, BRICS countries have championed developments in countries that exhibit great economic promise and have strong demand for infrastructure with the approved USD 32 billion infrastructure and sustainable development projects across four continents by the NDB. Additionally, via the BRICS cooperation, they have addressed global governance issues such as poverty alleviation, food security, and public health and approved an emergency line of USD 10 billion to assist BRICS member states



during the COVID-19 pandemic, demonstrating the strength of the BRICS cooperative mechanism.

In the face of this century of dynamic changes and challenges, the BRICS mechanism has provided opportunity and platform for EMDCs to build an open, inclusive, cooperative, and win-win partnership to deepen the South-South cooperation. Malaysia was one of the invited countries to participate in the High-Level Dialogue on Global Development held on 24 June 2022, jointly with the 14th BRICS Summit. As one of the partners of the Global Development Initiative, Prime Minister Datuk Seri Ismail Sabri Yaakob's statement at the Dialogue reflected Malaysia's commitment to international development cooperation and accelerating the implementation of the UN's 2030 Agenda for Sustainable Development. With the widening gap between the developed and developing economies, it is imperative to strengthen the cooperation and coordination amongst the EMDCs, to strive for greater representation and voice on the international stage.

FLOURISHING WITH BRICS PLUS

- The "BRICS Plus" format was initially proposed by China in 2017, and under China's BRICS chairmanship this year, the basis for tangible models for cooperative frameworks has already been announced by the representatives of the BRICS countries.
- BRICS Plus will include an enlarged platform that comprises countries in the African Union in Africa, the Community of Latin American, Caribbean States in Latin America, and the Eurasian economies from the Global South.
- The idea behind BRICS Plus is an effort to provide a forum where leaders from like-minded emerging economies come together to pursue a new paradigm of global development which is equitable and environmentally sustainable to capitalise on the rapidly rising economies of Asia, Africa, and Latin America.
- Malaysia, as a part of the ASEAN, is a promising candidate to benefit from the expansion of BRICS Plus, as the world is pivoting to Asia-Pacific, where the region is projected to have the fastest and largest growing markets.
- Malaysia is one of the most successful Southeast Asian economies and is on the precipice of becoming a highincome country; it has great influence over the geopolitical and socioeconomic over the Asia-Pacific region.


